

Rules for Visitors – Flatten the COVID-19 Curve

The following rules for visitors are a condition of entry to the museum.

The rules are excerpts from orders issued by the California Department of Public Health and the County of Los Angeles Department of Public Health, copies of which are available upon request.

- Groups are limited to household members only. Gatherings and events, including birthday parties, are not permitted.
- Visitors arriving at the museum are asked to use hand sanitizer.
- Visitors arriving at the museum are instructed to wear a face covering while in the museum, on the museum grounds and on the nature trail. This applies to all adults and to children over the age of 2. Only individuals with chronic respiratory conditions or other medical conditions that make use of a mask hazardous are exempted from this requirement.
- Symptom checks will be conducted before visitors may enter the museum. Checks must include a check-in concerning cough, shortness of breath or fever and any other symptoms the visitor may be experiencing. Visitors who are sick with respiratory symptoms will be instructed to go home.
- Visitors to the museum will be asked to register in a visitor log by providing a name, phone number and email address at the time of ticket purchase. This is to facilitate notifying you in case a COVID-19 exposure happens during your visit.
- Visitors arriving at the museum with children must ensure that their children stay next to a parent, avoid touching any other person or any item that does not belong to them, and are masked if age permits.
- The museum has been converted to one-way travel, and each exhibit gallery/room has been limited to one household group at a time to ensure physical distancing of at least 6 feet by visitors. Please do not enter a room until the previous household group has moved to the next room.
- Lines for the restrooms are located outside. Please stand 6-feet apart while waiting in line. (Members of the same household or living unit do not have to remain 6 feet apart from each other)

AV Indian Museum Disinfection/Cleaning Schedule

What is disinfected or cleaned?	Schedule
Credit card readers, pens	After each customer
Door handles and push bars	Disinfected 3 times a day
Metal hand rails	Disinfected 3 times a day
Metal folding chairs	Disinfected 3 times a day
Restrooms	Disinfected 3 times a day
Floors	Cleaned once a week
Display case glass	Cleaned once a week
Museum artifacts	NOT disinfected or cleaned (Please do not touch)
Historic furniture	NOT disinfected or cleaned (Please do not touch)
Historic building features (Painted walls, decorative wood, rocks, etc.)	NOT disinfected or cleaned (Please do not touch)
